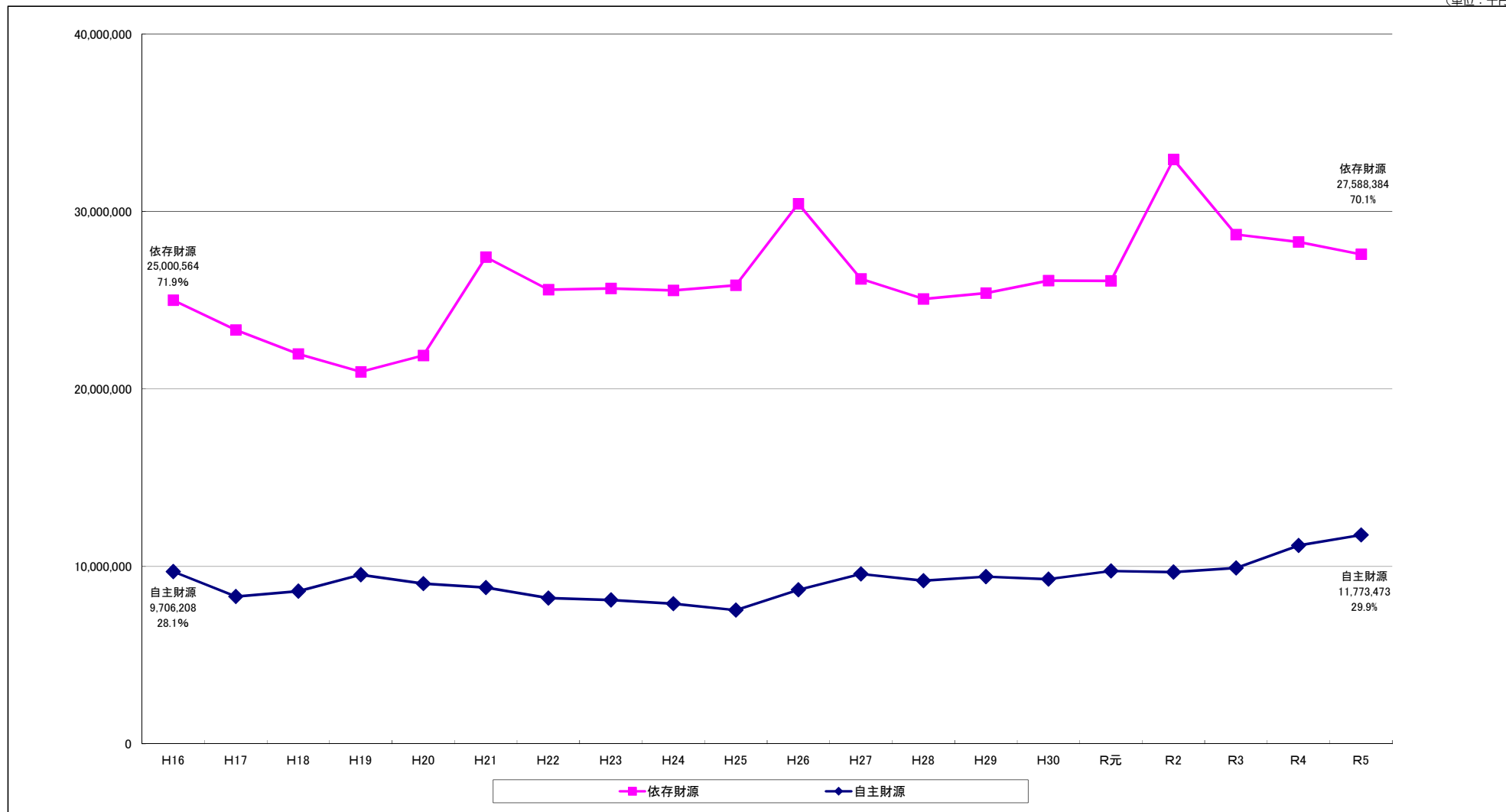

■年度別 歳入の財源区分の推移

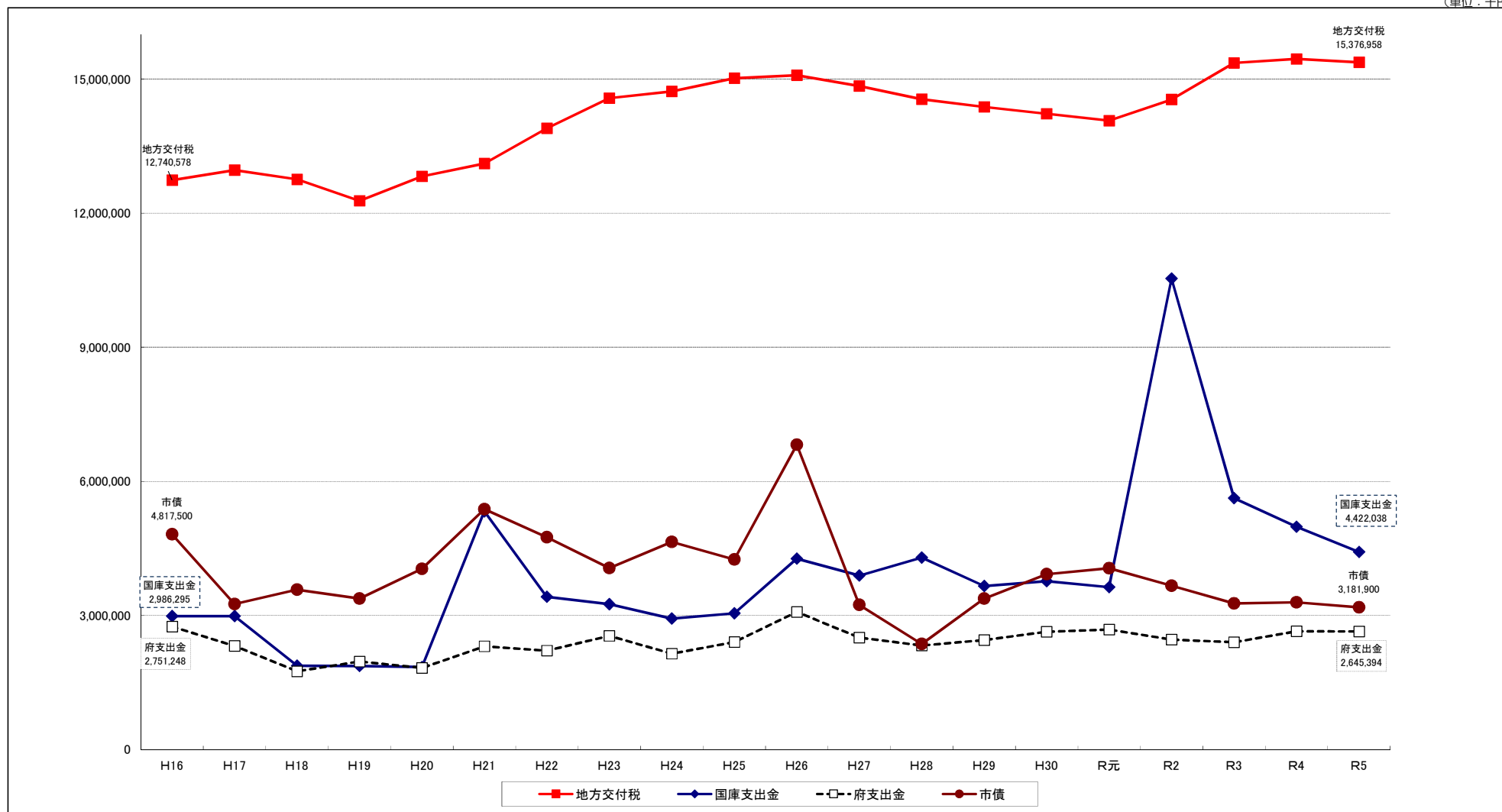

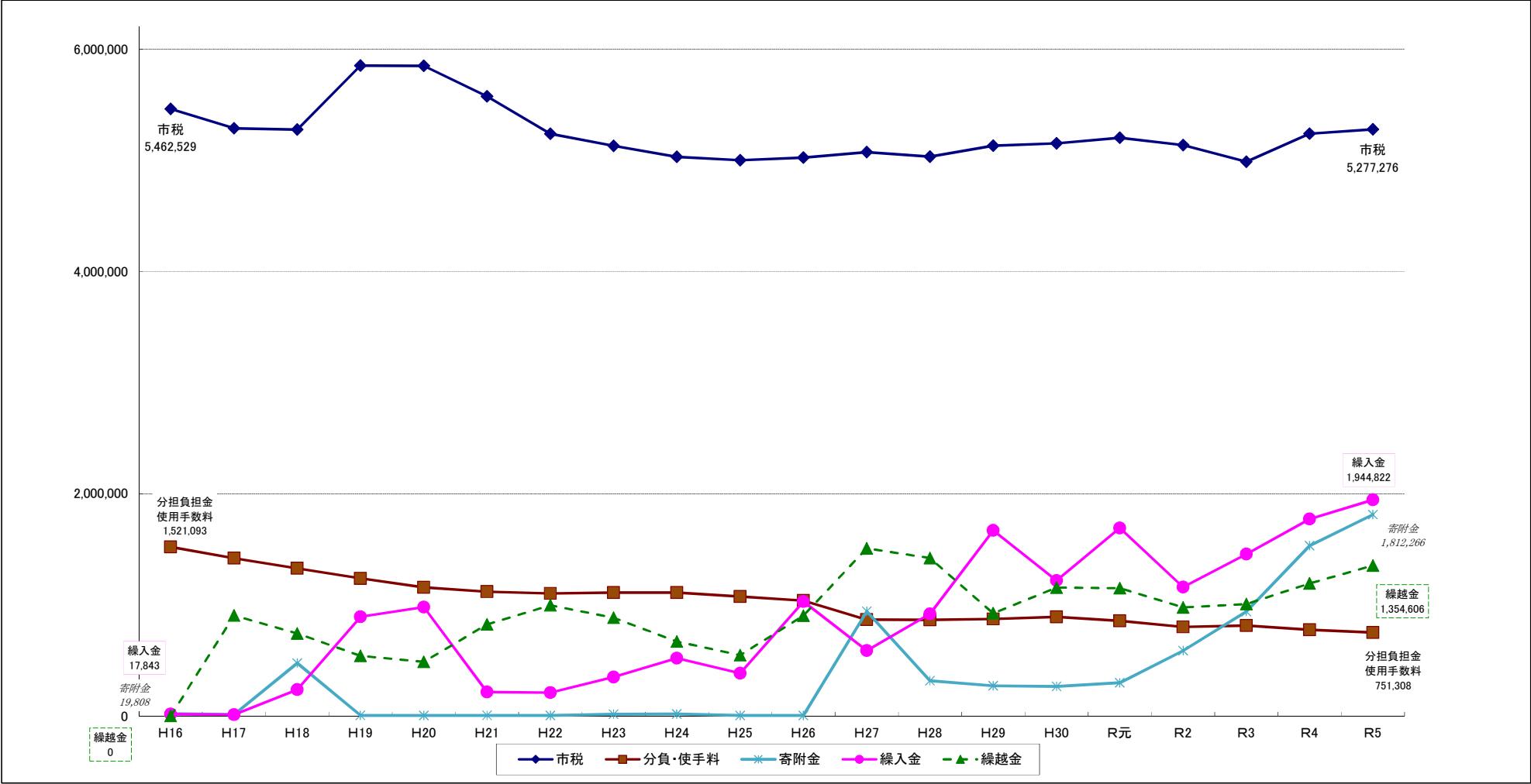

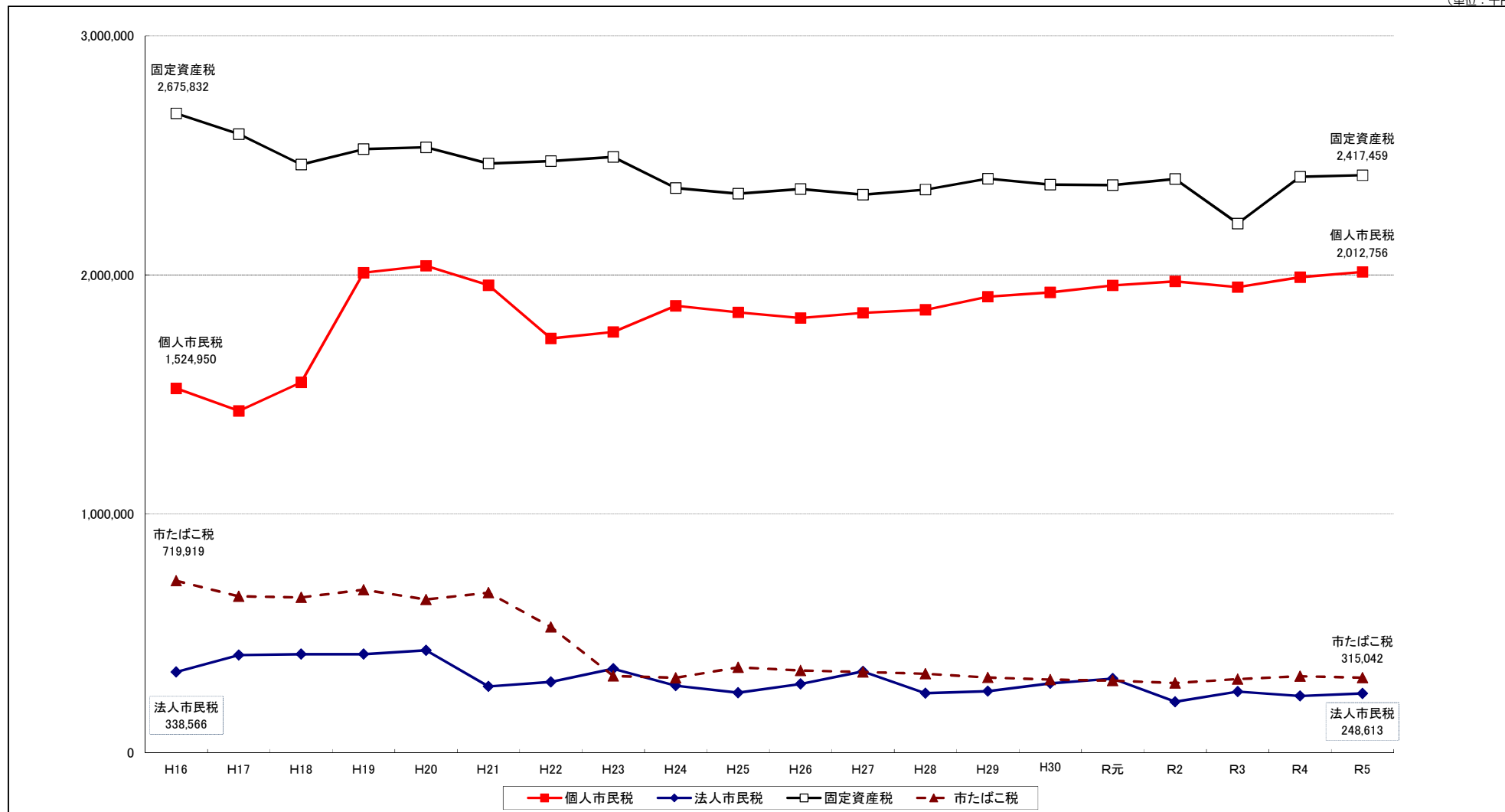

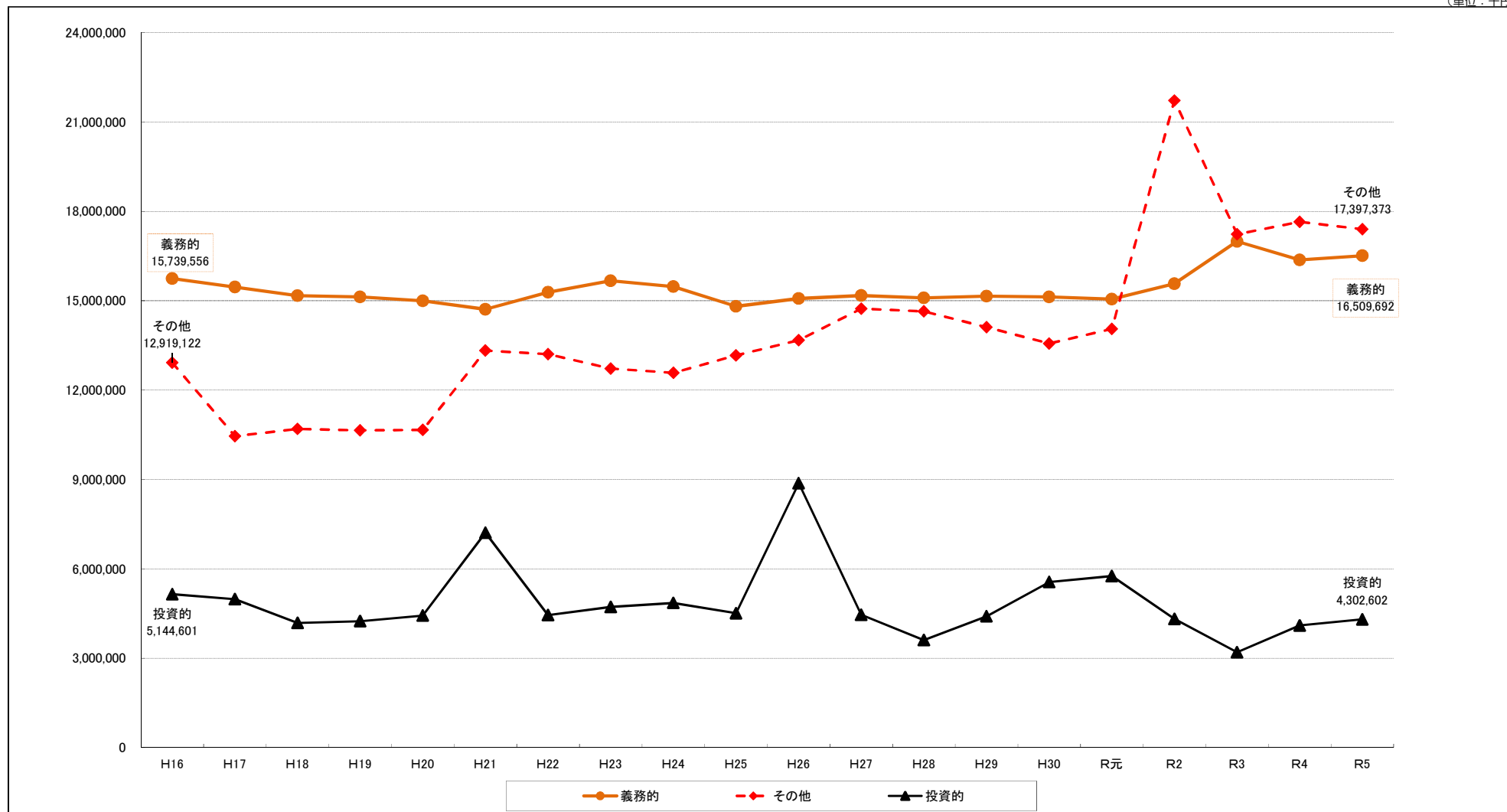

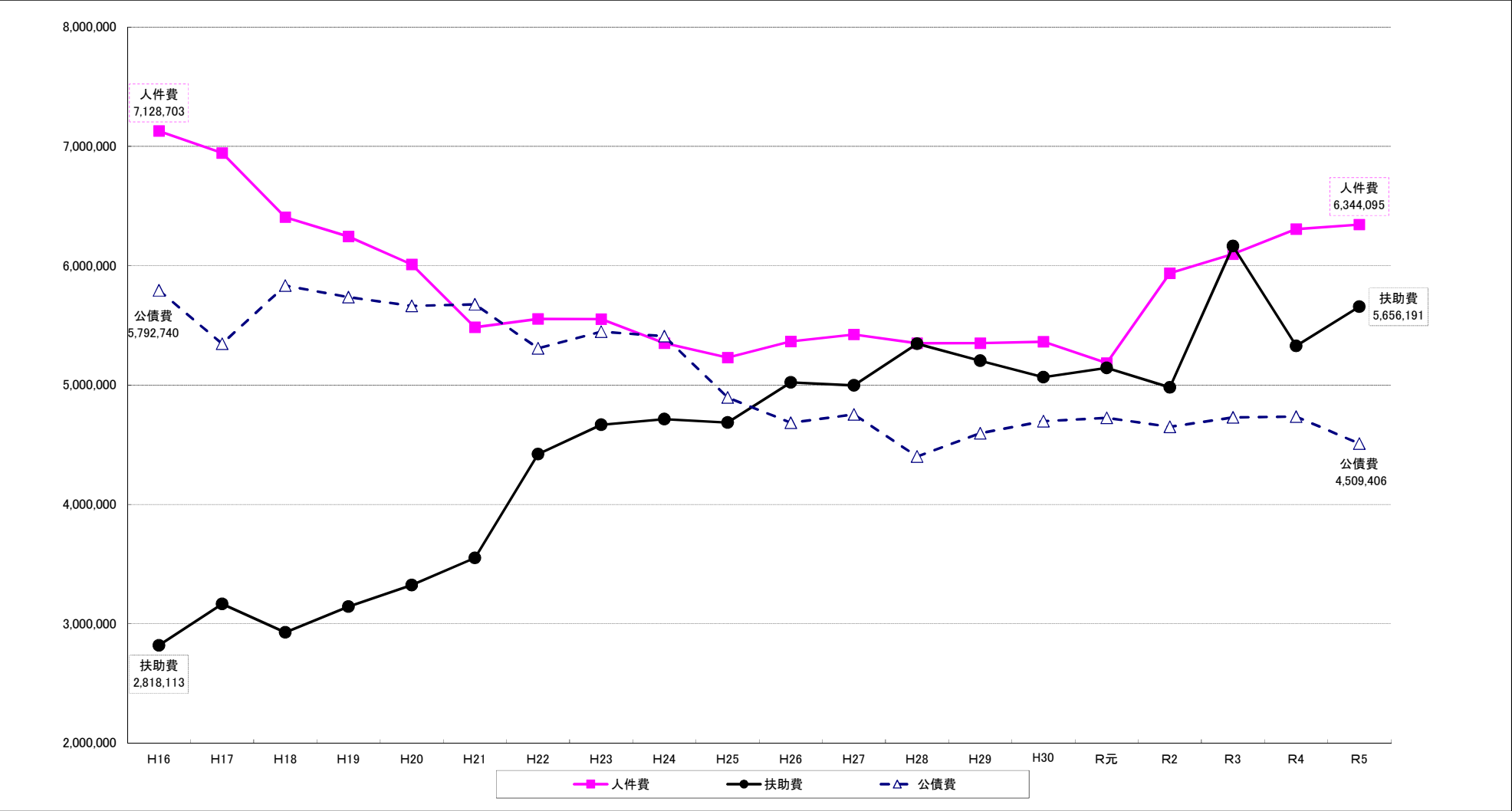

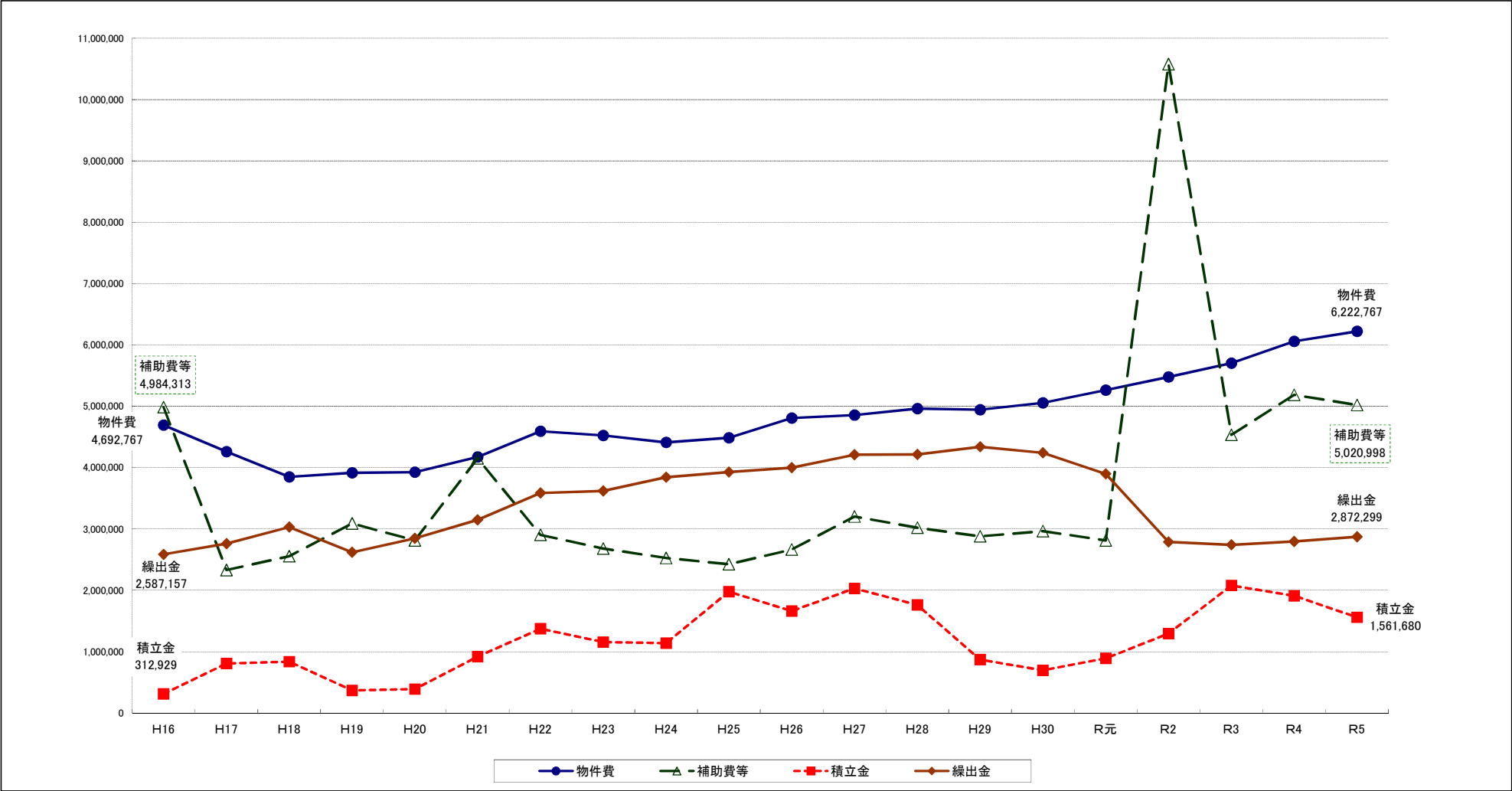

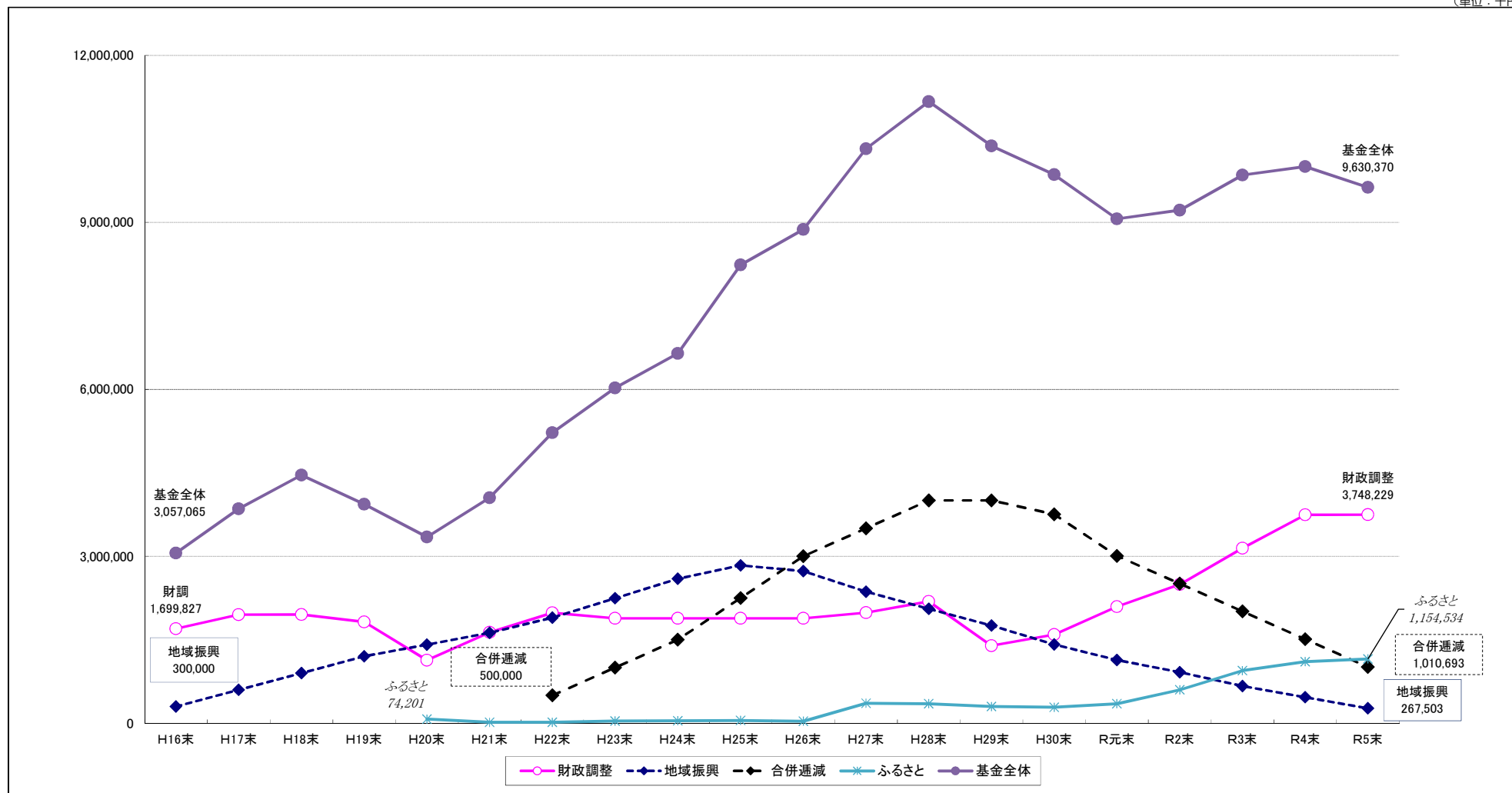

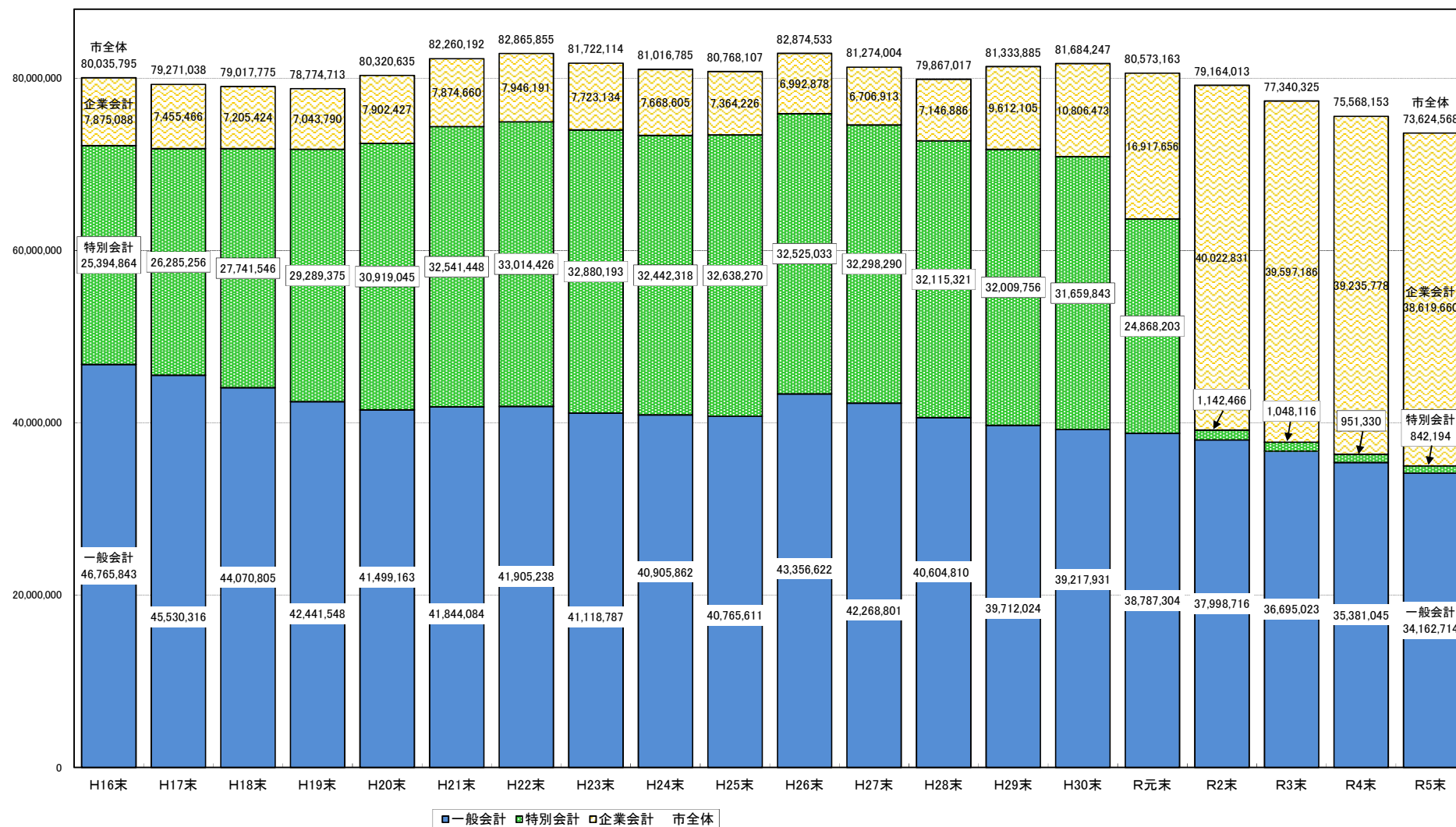

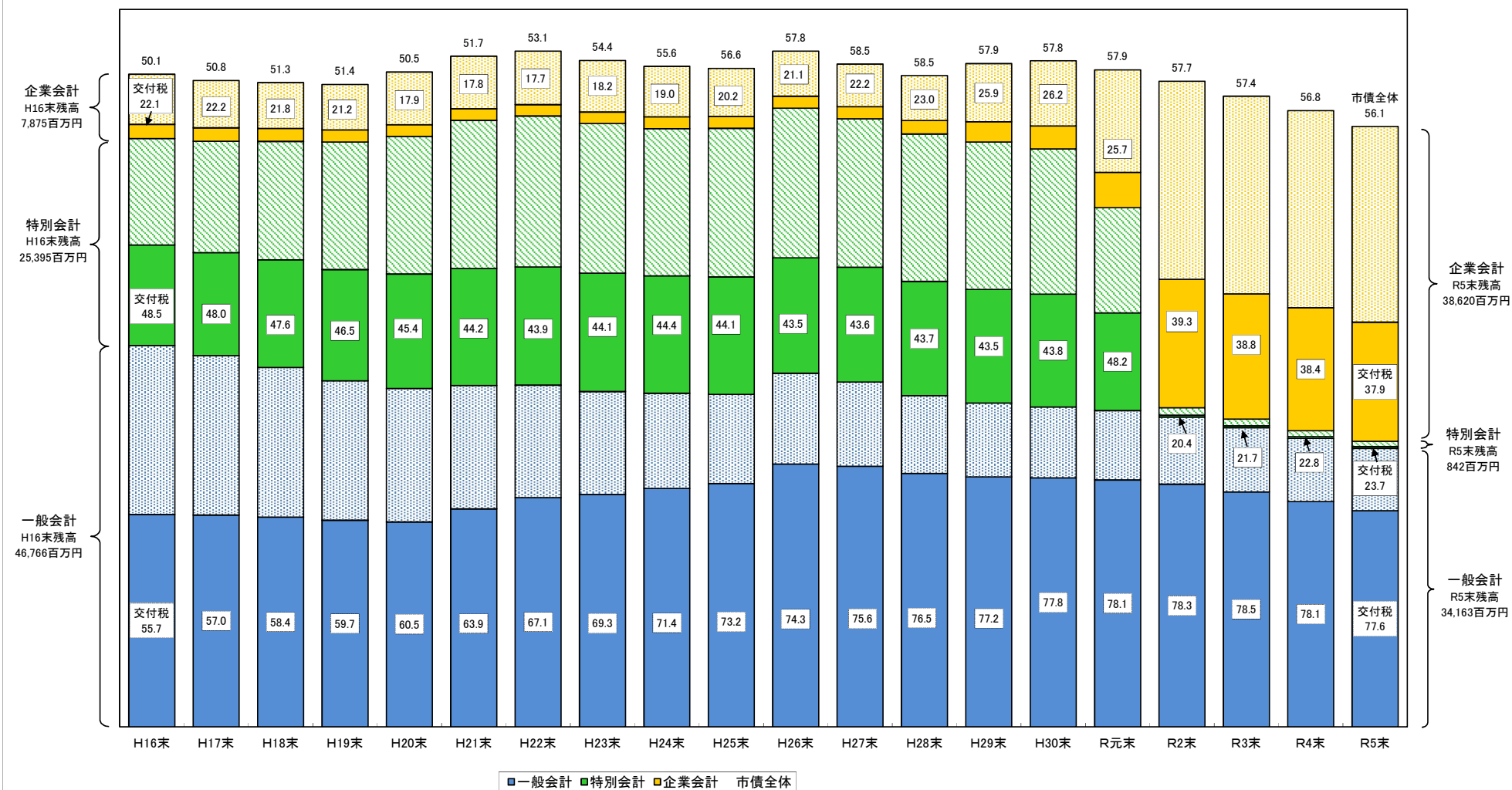

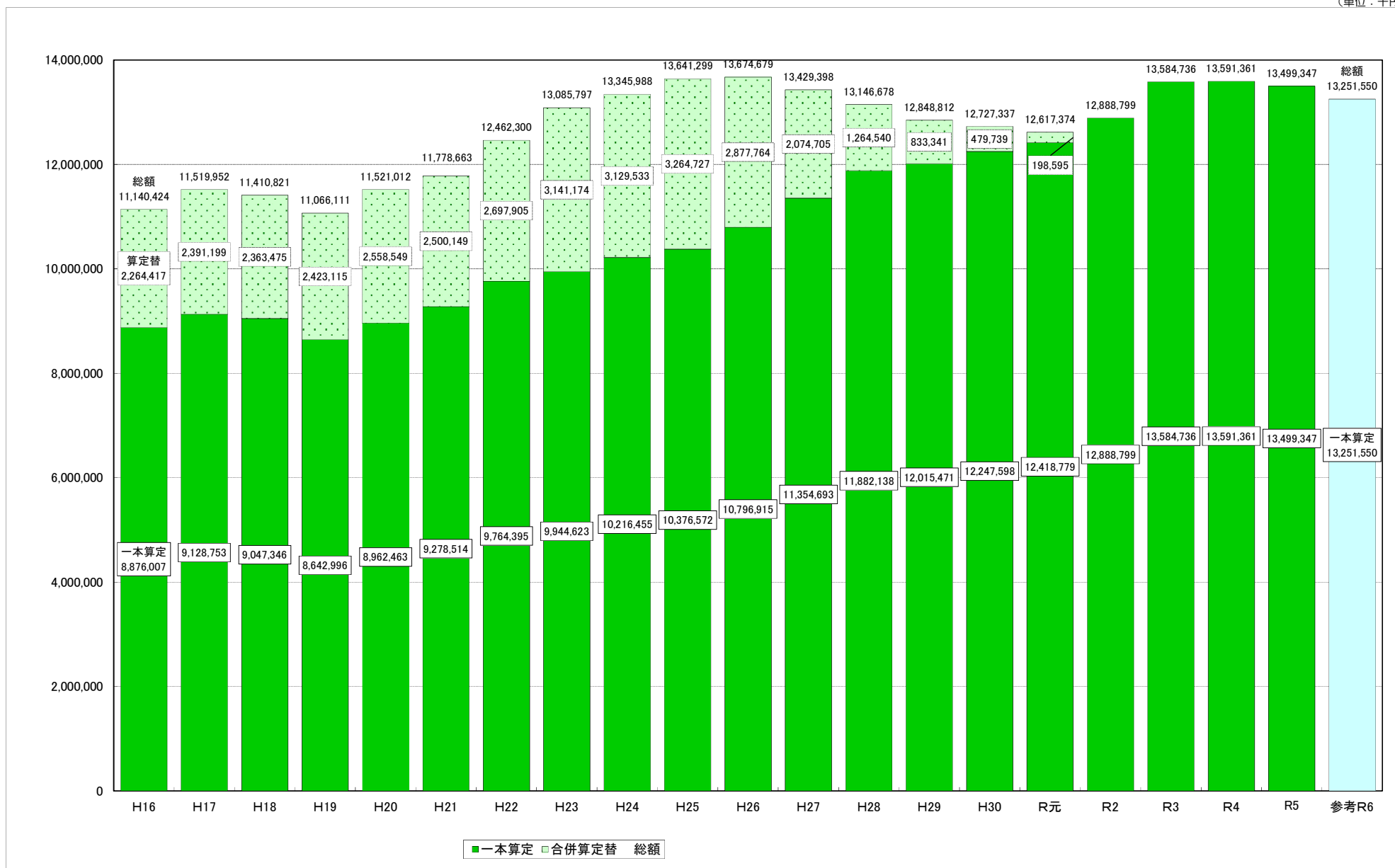
